We know these requests are looking for the President's vital records information because no one else ever requests index data. Index data is defined at <a href="http://hawaii.gov/health/vital-records/obama.html">http://hawaii.gov/health/vital-records/obama.html</a> and its purpose was to help people confirm their birth records are at the department before they pay to order their own records.

These recent requests will involve the department printing 300-400 pages of first and last names and gender and several hours of a staff person's time (for one year of index data). We have already confirmed on our website that President Obama's name is included in our index data. Please call me if you have further questions.
