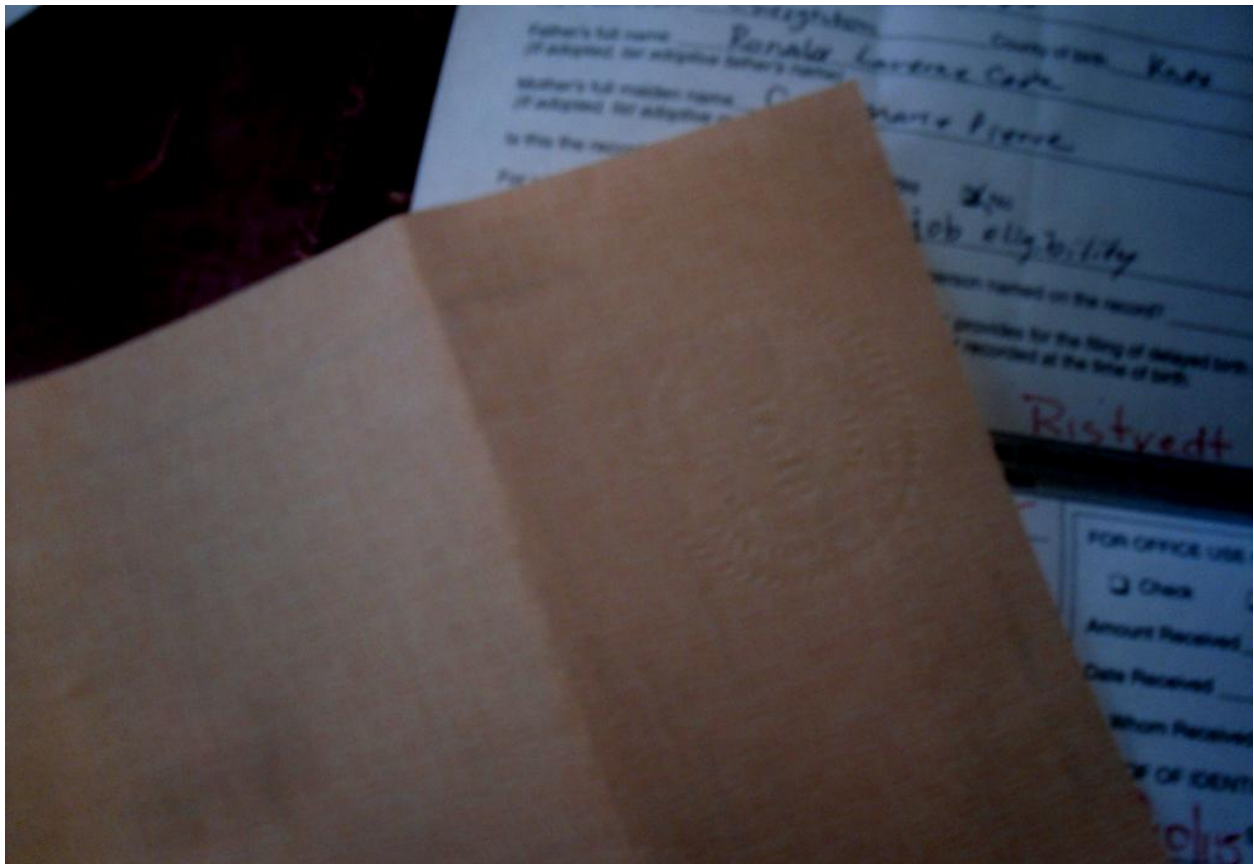


Now I'll post the stuff from the birth certificate that I requested in order to work in the after-school program in August of last year. Thank God for my daughter's camera. As of August 19, 2011 the State of Nebraska WAS using non-computerized embossed (raised) seals on their certificates of live birth. But I've got photos of Melinda's Certificate of Fetal Death (printed in 1993) that has a smaller computerized (created with dashes) debossed seal. The images of that seal are posted elsewhere on my blog.

I just posted the images of Tabitha's birth certificate which was printed out in 2005 when she was preparing to start kindergarten; it also has a computer-generated smaller image that is debossed, and it has a different design also.

And now I'm going to post images of my birth certificate and the documentation of having requested, received, and paid for that birth certificate on Aug 19, 2011. The birth certificate has a larger, non-computer-generated embossed seal. I'll increase the contrast so the seal shows up better
